RIGHT OF RESIDENCE OR LIFE INTEREST CLAUSE IN WILLS

A right of occupation provides a personal right for a person to continue to reside in property for a specified timeframe, or their lifetime. It is not transferable to another person, and has no monetary value. It is possible to include a provision allowing the recipient to transfer the right to a substituted property, depending on your wishes.

A life interest is an ownership right in something for life. This may be limited to a property, or may cover other assets as well (or instead). It allows the recipient to change the type of asset and receive any income generated by the asset. The recipient generally has more flexibility in the use of the asset(s), and there is a monetary value associated with this type of benefit. Limits can be placed on this, or the Will provisions may expressly extend the rights of the recipient, depending on your wishes.

These types of provisions are most commonly used in blended family situations.

REVIEW OF EXISTING TRUST DEED FOR SUCCESSION PURPOSES

Assets held by a Trust are generally not able to be directed to your nominated beneficiary/ies in a Will. If you have an interest in an existing Trust, we will need to review the terms of the existing Trust Deed(s) and supplementary documentation for estate planning purposes to determine whether the Will may have any impact on how control of the Trust can pass on your death. In some cases, supplementary documentation is required to ensure that assets in Trusts can pass in accordance with your objectives. We also need to check the recent accounts to see if there are any loans or unpaid entitlements, or any other element of the accounting which may have an impact on your estate plan. Please note that this review is limited to estate planning objectives only. It does not include a more general review of the trust or advice relating to any element of the trust's establishment or operation outside of this limited scope.
